Dear Directors,

The undersigned Contractor declares that he has carefully examined the location of the proposed construction site, the contract documents, and the plans and specifications therein referred to, and he proposes and agrees if this proposal is accepted, that he will contract with the District to provide all necessary machinery, tools, apparatus, and other means of construction and do all the work specified in the contract in the manner and time therein set forth required for:

The undersigned has checked carefully the above figures and understands that the District shall not be responsible for any errors or omissions on the part of the undersigned in making up this bid.

If this proposal shall be accepted and the undersigned shall fail to contract as aforesaid or to furnish bonds as provided in said specifications with sureties satisfactory to the District, or provide insurance or insurance certificates as provided in said specifications satisfactory to District within fifteen (10) calendar days after award of the contract, the District may, at its sole option, determine that the bidder has abandoned the contract and the District may offset any increase in costs for doing the within work against the bid bond as provided in the Information For Bidders document which is a part of the Contract Documents.

- 1) Pursuant to and in compliance with your Notice Inviting Sealed Proposals and the Contract Documents relating to the Rehabilitation of the El Pueblo Water Treatment Plant Clear Well Tank, Potable Water Treatment Plant, Scotts Valley Water District the undersigned bidder, having become thoroughly familiar with the terms and conditions of the Contract Documents and with the local conditions affecting the performance and costs of the work at the place where the work is to be done, and having fully inspected the site in all particulars, hereby proposes and agrees to perform fully the work within the time stated in and in strict accordance with the Contract Documents (including the furnishing of any and all labor and materials) and do all the work required to construct and to complete said work in accordance with the Contract Documents.
- 2) It is understood that The District reserves the right to reject this bid, but that this bid shall remain open and shall not be withdrawn for a period of sixty (60) days from the date prescribed for its opening.
- 3) Attached hereto and incorporated herein is the complete and entire list of subcontractors to be employed by the undersigned in the performance of the work.
- 4) If written notice of the acceptance of this bid is mailed or delivered personally to the undersigned within sixty (60) days after the date set for the opening of this bid, or at any time thereafter before it is withdrawn, the undersigned bidder shall execute and deliver the Contract Documents to The District in accordance with this bid as accepted, and will also

furnish and deliver to The District the Performance Bond, Payment Bond as specified and proof of insurance coverage as required in the General Conditions, all within fifteen (15) days after personal delivery or after deposit in the mails, of the notification of acceptance of this bid. The above mentioned bonds shall be in form satisfactory to the General Manager of the Scotts Valley Water District and on the forms approved by The District. Proof of insurance coverage shall be in the form of an insurance certificate which shall meet the requirements specified in the General Conditions and shall be satisfactory to the General Manager.

- 5) Notice of acceptance or request for additional information may be addressed to the undersigned at the address set forth below.
- 6) The undersigned declares that this bid is not made in the interest of or on behalf of any undisclosed person, partnership, company, association, organization or corporation; that the bid is genuine and not collusive or sham; that the undersigned has not directly or indirectly induced or solicited any other bidder to put in a false or sham bid and has not directly or indirectly colluded or agreed with any bidder or anyone else to put in a sham bid or to refrain from bidding; that the undersigned has not directly or indirectly sought by agreement, communications or conference with anyone to fix said bid price or the bid price of any other bidder, or to fix any overhead, profit or cost element of such bid price or of that of any other bidder, or to secure any advantage against the District or anyone interested in the proposed contract; that the only persons or parties interested in this bid as principals are those named herein; that all statements contained in this bid are true; that the undersigned has not directly or indirectly submitted undersigned's bid price or any breakdown thereof, or the contents thereof, or divulged information or data relative thereto, to any other persons, partnership, corporation or association except to such person or persons as have a direct financial interest in bidder's general business; and that the undersigned has not accepted any bid from any subcontractor or material person through any bid depository, the By Laws, Rules or Regulations of which prohibit or prevent the undersigned from considering any bid from any subcontractor or material person, which is not processed through said bid depository, or which may prevent any subcontractor or material person from bidding to any general Contractor who does not use the facilities of or accept bids from or through such bid depository.
- 7) Wherever in this bid an amount is stated in both words and figures, in case of discrepancy between words and figures, the words shall prevail; if all or any portion of the proposal is required to be given in unit prices and totals and a discrepancy exists between any such unit prices and totals so given, the unit prices shall prevail.
- 8) The undersigned certifies that the Contract Documents have been thoroughly read and understood and that, except as may be specifically noted and contained in addenda, there are no discrepancies or misunderstandings as to the meaning, purpose or intent of any provision in the Contract documents or as to the interpretation of the same. The undersigned hereby incorporates by reference, the same as though set out in full, all provisions of the Notice Inviting Sealed Proposals and Information for Bidders published by The District and pertaining to the work described in this bid.

Bid prices shall include allowance for all federal, state and local taxes.

The terms and conditions of the final contract when executed shall control and supersede anything herein to the contrary or inconsistent with such contract.
